## 177/17 Apologies

# 181/17 Ongoing Items (Matters Arising from Previous Minutes)

- Old railway line footpath: Cllr. Capstick was not present but work had not yet started on making the path.
- Cumbria County Council to repaint the signpost at the bottom of Woodhouse Lane: This had now been done.
- New flower bed at the north end of the village: The work would commence in better weather.
- Parking near Crow Wood and Old School: Cllr. Richards reported that he was still awaiting a decision from SLDC with regard to the parking area..
- Grievegate milestone plaque: The Clerk was asked to make enquiries with regard to the purchase of a plaque.
- Risks associated with council owned land: Cllr. Rendell was not present so this was deferred to the next meeting.
- Monument: The bench had not yet been ordered as it was thought that the concrete fixing and the pointing of the paving around the plinth would best be done in the spring.
