It was agreed to review this when the financial statements to 31 July 2022 were received. It was reported that there was to be a fund-raising event in two weeks. The Clerk was asked to ascertain whether free electric car charging points were still available and, if so, to forward the details to the Committee for discussion about putting a charging point in the car park
