#### 124/23 Apologies

Apologies were received from Cllrs. Brian Rendell, Tom Grindey, Iain Richards and Elizabeth Moffat (reasons all accepted and noted) and Westmorland & Furness Cllr. Janet Battye Condolences were expressed to Cllr. Grindey on the death of his mother

#### 125/23 Minutes

Resolved that the minutes of the meeting held on 10 August 2023 be confirmed as a true record and be signed by the Chair

#### 129/23 Ongoing Items

- Queen's Platinum Jubilee Tree Scheme Plaque: It was agreed that this should be left until the new trees are ready for onward planting
- Extension of 50mph limit to Levens Bridge: There was no further information to report
- Proposed village 20mph zone: It was agreed that this should go on the next agenda for review once the new W&FC policy has been clarified
- Field of Dreams: A reply to the Council's claim was awaited. It was noted that the wall repairs had been done
- Temporary Bus Stops: There was no further information yet but enquiries were being made through W&FC
- Village Fire Hydrants: The Fire Service had stated that there was no problem with the water pressure at the Woodhouse Lane fire hydrant
- Street Light Removal: The Clerk had not yet met with the Council's lighting contractor
- Grants and Donations Policy: Amendments were discussed and agreed
- Climate Change Working Group: As Cllr. Richards as not present, this was postponed to the next meeting

#### 130/23 Reports

- a. Westmorland & Furness Cllr. Battye had sent a written report referring to the 20mph scheme, winter gritting, adult health and "climate conversations" on the action plan.
- b. The Athenaeum: The Receipts and Payments Accounts, Trustees' Annual Report and the Independent Examiner's Report for the year ended 31 July 2023 were received. **Resolved** that both the Accounts and the Annual Report be approved by the Council and signed by two Trustees. The Council's thanks were expressed to both the Treasurer and the Independent Examiner. The annual general meeting is to be held on 4 October 2023

# 131/23 Planning

i) It was noted that the following planning applications had been **submitted** to W&FC and circulated to members of the Council since the last meeting:

# SL/2023/0614 Valley View, Leasgill

Replacement dwelling

The Council resolved to **object** to this application as it was believed that it did not comply with the requirements of the Neighbourhood Plan and the South Lakeland Local Plan, which both state that developments should be sympathetic to the surroundings and character of the area

#### SL/2023/0663 Grievgate, Leasgill

Replacement of conservatory with extension and associated external works, alteration to existing openings and addition of stone facing

The Council had **no comments** to make on this application

ii) It was noted that the following planning application had been notified as approved by SLDC since the last meeting: TR/2023/0082 Beech Tree Barn, Heversham Gardens, Heversham

T1 beech - crown reduce by 2-3m, crown thin by 20% & crown raise by up to 6m

iii) The Chair stated that the Neighbourhood Plan group had considered the email which had been received from another council concerning a planning decision which they believed could result in Neighbourhood Plans becoming irrelevant. The group were of the opinion that it was not a Neighbourhood Plan issue and it was therefore resolved to take no action

# 132/23 Highways / Footpaths / Trees and Woods Highways:

- a) Potholes continued to be reported on HIAMS
- b) It was noted that the Parkhouse sign had been replaced but that it was facing in the wrong direction
- c) The proposal by another group for the cleaning of road signs had not proceeded
- d) An update had not yet been received regarding the Dallam School pupils' proposal for additional lighting on the A6 between Heversham and Milnthorpe

e) An email had been received concerning the Bay Cycleway signs being moved. This had been reported on HIAMS and the situation was being monitored

# Footpaths/Tracks:

i) A meeting was being arranged with the Footpaths Officer at Westmorland and Furness Council

### **Trees and Woods:**

- The Dallam School trustees' meeting had confirmed that the Council had continued responsibility for the trees on the old railway line. The Chair reported that Cllr. Richards had agreed to monitor the safety situation and that a meeting was to be arranged with the person doing the same for Dallam School
- ii) As Cllr. Rendell was not present, the action regarding the beech tree was deferred until the next meeting

# 133/23 Playground Report

- i) Cllr. Rendell had inspected the playground since the last meeting and reported no problems
- ii) Cllr. Rendell continued to monitor the equipment and would carry out the inspections until the next meeting
- iii) It was noted that the seesaw and picnic table had been delivered and the seesaw was awaiting installation
